- 1. Meet the new Ohio Democratic Chairwoman, Liz Walters

 - i. What's next for the Democrats Look at the party to marshal our resources and strategically move forward.
 - 1. Organize build grass roots infrastructure and gain access to activities and activision to pull all of us together.
